Sl No	Query	Clarification
1	What should be the value and validity of Solvency Certificate	The solvency certificate should be for atleast Rs. 30 Lakhs. The certificate should be recent with a validity of atleast 6 months.
2	Security Deposit and EMD clarification	EMD is the bid security money to be deposited with the tender document. The SD will be applicable only to the successful bidder post award of contract.
3	Price Bid - Unscheduled Vehicles - Toyota Etios	Bidders should quote for Toyota Etios or Equivalent vehicles like Suzuki Dzire, Hyundai Accent, Tata Indigo etc.
4	Minimum 5 years experience for driver - clarify	The validity of the driver's licence should be atleast 5 years. The validity of the badge can be of a shorter duration.
5	Whether GST is applicable?	GST @ 5% is applicable. Bidders are requested to mention the same separately in the price bid.
6	Whether toll charges will be reimbursed?	Yes, toll charges will be reimbursed only when attached and claimed with the trip sheets/bills.
7	Any weightage for new or showroom vehicles	No weightage for new or showroom vehicles. All vehicles should be 2014 or later model only.
8	Which part of the document should be enclosed in price bid	Pages 1-16 of the tender document should be part of Technical bid and Pages 17-23 should be part of Price bid.
9	Price variation on fuel price escalation	Since the fuel price variation is variable on a daily basis, the quote for scheduled buses should be valid for one year considering the fuel escalation for the whole year. For scheduled and unscheduled vehicles, the fuel escalation shall be considered on a quarterly basis, if there is a considerable variation. The calculation for the same shall be sent by the agency along with the monthly claims. The fuel price as on 10th August shall be considered while quoting.
10	Pt. no. 29 page 7 - Mileage on Mazda (32/ 41 seater)	The mileage on Mazda to be considered is 5 km for AC and 7 km for Non AC vehicles.
11	Performance Certificates	Minimum 2 performance certificates dated after 01/01/2016 shall be provided.
12	Geographic location to service Centres operations	Proximity to the Centre/ pick up points will carry more weightage. The agency should give an undertaking of the time/ distance that will be additionally charged from the garage to ICTS and back (Applicable for scheduled and unscheduled cars only).
