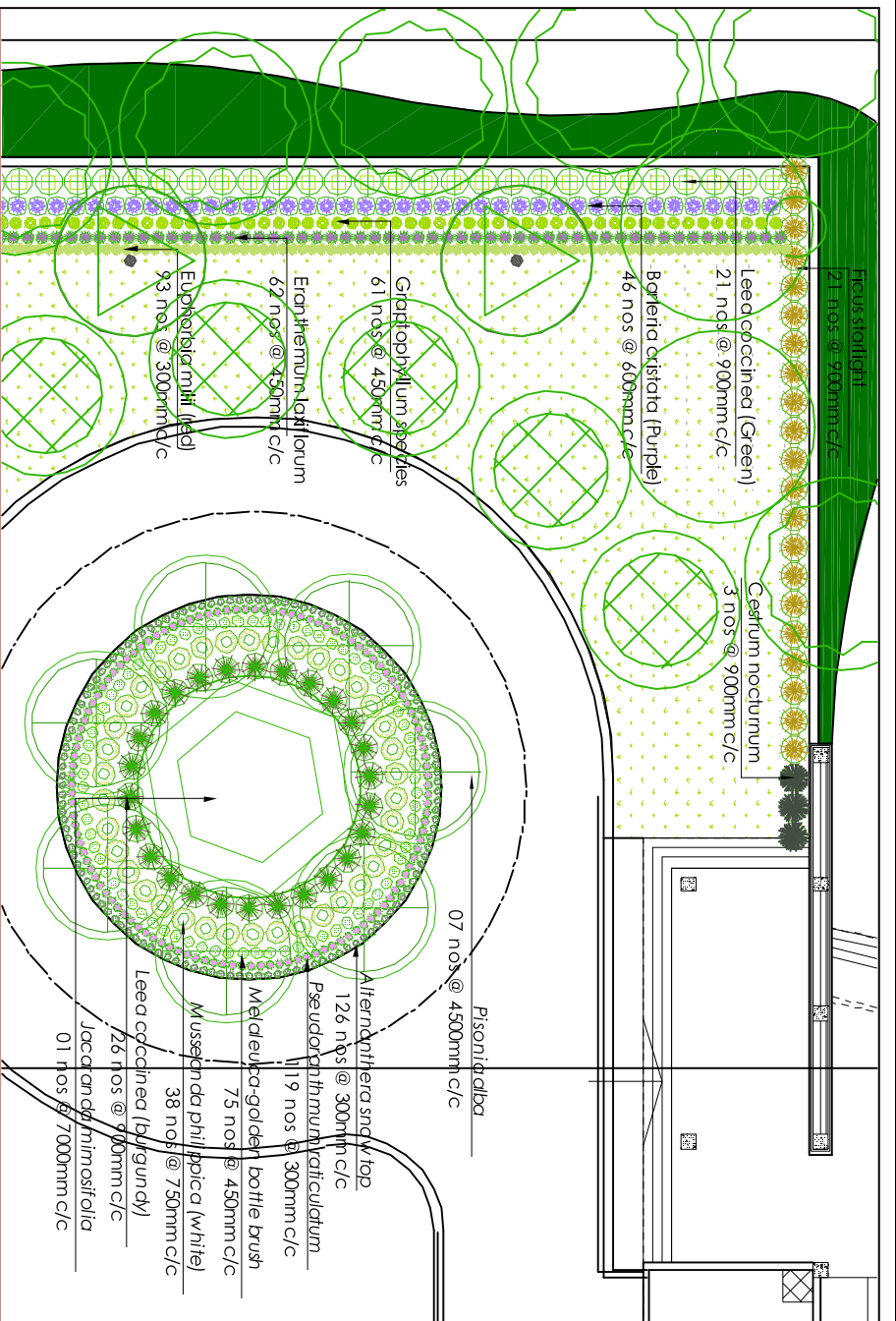


Detail of planting at intersection
