1	EMD Exemption for MSME/NSIC Certificate holders	Yes, MSME/NSIC Certificate holders for the particular category of service/nature of work are exempted from payment of EMD, however they are not exempted from SD and PBG.		
2	Whether ESI and PF is to be calculated on Rs. 15000	PF calculation may be restricted to Rs. 15000 salary. ESI not applicable for Gross salary exceeding Rs. 21,000. However, the agency should quote for Group Health Insurance equivalent to ESI and provide insurance to the contract staff.		
3	Uniform and Washing Charges	Uniform and Washing charges (600+200) will be applicable to all categories of staff. The same should be considered accordingly in the Price Bid. Corrigendum attached herewith.		
3	Is Solvency Certificate mandatory?	Yes, Solvency certificate for a minimum value of Rs. 14 lakhs dated on or after 01.01.2024		
4	Which Minimum wages should be followed, state or central?	Central minimum wages Act to be followed.		
5	Applicability of Bonus	Bonus is not applicable on Gross salary exceeding Rs. 21000.		
6	No. of days of Holidays and leave rules	Leave wages as quoted shall be paid in lieu of leave. National Holidays, Sankranti, Ganesh Chaturthi, Ugadi, Dussehra Puja and Deepavali will be holidays for the Sports Centre.		
7	Are overtime wages applicable?	No, overtime wages are not applicable.
