

- 4) Service to be made at ICTS-TIFR (at vendor's own arrangement), Survey No. 151, Shivakote Village, Hesaraghatta Hobli, Bangalore North 560089.
- 5) Delivery & Installation Period: 3-4 weeks from the date of acceptance of the order.
- 6) Liquidated damage: In case the item is not supplied within the agreed delivery schedule and after a grace period of 07 days, then liquidated damages will be imposed automatically and will be deducted from the bill of the vendor at the rate of 0.5% per week, subject to a maximum of 10% of the order value.
