- 5) Delivery to be made to ICTS-TIFR (at vendor's own arrangement). Transit Insurance should be done up to International Centre for Theoretical Sciences-TIFR, Survey No. 151, Shivakote Village, Hesaraghatta Hobli, Bangalore North – 560089.
- 6) Delivery Period: 6 weeks from the date of acceptance of the purchase order and Installation within 2 weeks from delivery.
