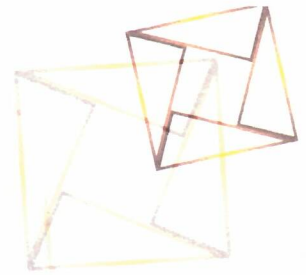

- 1) **DUE DATE FOR SUBMISSION OF QUOTATION AGAINST THIS ENQUIRY IS 26/07/2018 till 15.00 Hours.**
- 2) QUOTATIONS RECEIVED AFTER THE DUE DATE SHALL BE REJECTED.
- 3) Vendors can quote in USD also.
- 4) The Validity of your quotation should be for 60 days from the date.
- 5) Your quotation should include 3-year warranty. 4<sup>th</sup> and 5<sup>th</sup> year additional warranty is mandatory and should be quoted separately. Additional warranty will be considered for commercial evaluation, but the Centre reserves the discretion to include/exclude the 4<sup>th</sup> and 5<sup>th</sup> year warranty in the Order.
- 6) The bidder should submit the MAF (Manufacturer's Authorization Form) Certificate.
- 7) Delivery to be made to ICTS-TIFR (at vendor's own arrangement). Transit Insurance should be done up to International Centre for Theoretical Sciences-TIFR, Survey No. 151, Shivakote Village, Hessarghatta Hobli, Bangalore North – 560089.
- 8) Delivery Period: 4 weeks from the date of acceptance of the purchase order and Installation within 1 week from delivery.
- 9) Liquidated damage: In case the item is not supplied within the agreed delivery schedule and after a grace period of 07 days, then liquidated damages will be imposed automatically and will be deducted from the bill of the vendor at the rate of 0.5% per week, subject to a maximum of 10% of the order value.
- 10) **Payment:**
  1. In case of import **80%** of the payment shall be made through sight draft and balance **20%** of the amount shall be released after the receipt, installation, commissioning on acceptance of the equipment and on submission of performance bank guarantee for an amount equivalent to 10% of the Purchase Order value.
  2. In case of local supply, the payment terms will be net 15 days, subject to satisfactory installation and commissioning.
- 11) Any dispute or differences that may arise between the parties shall be referred to the sole arbitration of the Centre Director or his nominees. The decision of the arbitrator shall be final and binding on the parties. The venue for arbitration shall be Bangalore. The provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time shall apply. The Courts in Bangalore shall have exclusive jurisdiction to deal with any or all disputes between the parties.
