





- 5) Your quotation should include 1-year warranty. 2nd and 3rd year additional warranty is mandatory and should be quoted separately. Additional warranty will be considered for commercial evaluation, but the Centre reserves the discretion to include/exclude the 2nd and 3rd year warranty in the Order.
- 6) Delivery to be made to ICTS-TIFR (at vendor's own arrangement). Transit Insurance should be done up to International Centre for Theoretical Sciences-TIFR, Survey No. 151, Shivakote Village, Hesaraghatta Hobli, Bangalore North - 560089.
- 7) Delivery Period: 8 weeks from the date of acceptance of the purchase order and Installation within 4 weeks
- 8) Liquidated damage: In case the item is not supplied within the agreed delivery schedule and after a grace period of 07 days, then liquidated damages will be imposed automatically and will be deducted from the bill of the vendor at the rate of 0.5% per week, subject to a maximum of 10% of the order value.
- 9) Payment: Within 15 days after delivery, acceptance & satisfactory installation.
- 10) Any dispute or differences that may arise between the parties shall be referred to the sole arbitration of the Centre Director or his nominees. The decision of the arbitrator shall be final and binding on the parties. The venue for arbitration shall be Bangalore. The provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time shall apply. The Courts in Bangalore shall have exclusive jurisdiction to deal with any or all disputes between the parties.
